FMCS Parents,

Please find attached the application form for financial assistance.

Christian education is an alternative program of the public school district and is not entirely funded by the district. In order to cover the costs associated with adding a Christian aspect to our programming, whether it is staff, teaching supplies or bible based curriculum, our families are required to pay fees based on the following:

One child, grade 1-9	\$100 per month / \$1000.00/year
Two children, grade(s) 1-9	\$150 per month / \$1500.00/year
Three or more children, grade(s) 1-9	\$175 per month / \$1750.00/year

Unfortunately, sometimes our families experience circumstances that prevent them from being able to contribute to the extent outlined in the previous table. God has blessed our school and provided for us so that each year, we have been able to set aside funds that are earmarked specifically for helping our families experiencing financial challenges.

With that said, when choosing the Fort McMurray Christian School, our families are expected to make both a personal and financial commitment to the teaching of our children based on scripture so that we train them up in the way that they should go - *Proverbs 22:6*. This is why our application asks for a monthly dollar value that each family feels they *can* afford to pay. Even though the entire monthly fee may not be feasible, we do believe that every family can make a commitment towards their child(ren)s educational expense. Please take some time to discuss with God and with your family as to what this amount should be.

Please be aware that a financial assistance application is required each year. Financial circumstances can change for both our families and our society. It is important that you get your application in as early as possible and meet with the society administrator to discuss the details in order for our executive to allocate funds appropriately and in a timely manner.

Simplified Process:

Step 1: Fill out application and submit to office by September 30th

Step 2: Meet with Society Administrator to discuss details of your application prior to September 30th

Step 3: Applications submitted to Executive for approval and results given to applicants by October 30th

Please note: Bus fees are set and imposed by the Public School District and are not subject to financial assistance by the FMCS society. If you choose to put your child(ren) on the bus, fees must be paid up front or with post-dated monthly cheque installments to the school office.
