a) Achievements or Accomplishments:

- The School Council Chair and the Principal had regular meetings throughout the school year.

- The School Council Chair and the FMCS Society Chair had regular meetings throughout the school year.

-The School Council members helped the FMCS Society with the Welcome Back BBQ.

- The School Council had 4 meetings; whilst being mindful of the CUPE Strike.

- The School Council did 4 Work Bees; whilst being mindful of the CUPE Strike.

- The School Council initiated a "Shirt Swap" for families to swap school merch for Pink Shirt Day, School Spirit Day, etc

- On March 24, 2025; the FMCS Society brought in guest speaker Brett Uhlman. He did a presentation in the morning for grade 5-9 students discussing social media and mental health. In the evening, he did a similar presentation aimed for parents. The School Council was able to financially contribute towards this event and are so thankful for the partnership with the FMCS Society for this event.

- The School Council members spent time in the FMCS Library, helping Librarian Mrs. Dalley; organizing, labelling, and helping with Book Fairs.

- School Council Chair attended the FMCS Education Plan presentation at the FMPSD on May 14, 2025 with Principal Bishop and Vice Principal MacIntosh.

- School Council members spearheaded a Plant Project to beautify school grounds, May/June 2025.

- Chair and/or the Networks Rep of the School Council attended the Networks Meetings in April 2025.

- School Council Chair attended the Trustee Information Session at FMPSD on June 10, 2025.

c) Issues:

d) How can the Board better assist the operation of School Advisory Councils?

- Due to the circumstances surrounding the CUPE strike, the School Council felt a lack of support from the FMPSD. The situation created challenges in communication and engagement, which impacted our ability to fulfill our role in supporting the school community. The FMCS School Council acknowledges the complexity and pressure of the circumstances and understands that many difficult decisions had to be made. We really missed those Network Meetings and connections made with other school council chairs, network reps and Trustees.

- The School Council members and families of FMCS are deeply grateful to the FMCS Society and the FMPSD for the opportunity to be part of an alternative Christian program. For many families, a Catholic education may not feel like the right fit, and having access to a Christian-based public education is something we value tremendously. This program offers an important choice that reflects our faith and educational priorities, and we are thankful for the ongoing support that makes it possible. As our students grow, so does our desire to see this program continue through high school. We strongly encourage the continued protection of the existing program and thoughtful investment in expanding it to include a Christian high school option within the public system.
